

ADULT EVENT WAIVER

The undersigned, being of the age 18 or above, desires to participate in the following event hosted by Teach For America South Carolina (TFASC), (hereinafter called, "The Event"): TFASC's 10-Year Anniversary Celebration. The Event begins at, _____, and ends at, _____.

1. **Consent to Participate:** I, _____, consent to participation in The Event.
2. **Personal Property:** I understand that TFASC is not responsible for my personal property and that I assume full responsibility for lost or damaged personal property during The Event.
3. **Assumption of Risks:** TFASC will take reasonable care to ensure the safety of all participants during The Event. However, participation in The Event carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the possible risks range from (1) minor injuries such as scratches and sprains to (2) major injuries such as eye and back injuries, and concussions to (3) catastrophic injuries including paralysis and death. If I should become injured while participating in The Event, I authorize TFASC to perform first aid and/or seek medical assistance, on my behalf, and I release TFASC from responsibility for such decisions made in good faith.
4. **Waiver of Liability:** I, for myself and my personal representatives, heirs, and assigns, waive any claim of liability against and agree to hold harmless TFASC from any and all actions, causes of action, judgments, costs, expenses, claims or demands, of every kind and character (including reasonable attorneys' fees), arising from my participation in all or any part of The Event, except such liability or claim of liability as may result from gross negligence on the part of TFASC.
5. **Severability:** I expressly agree that the above personal property, waiver of liability, and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of South Carolina and that if any portion is held invalid, it is agreed that the balance of the agreement will continue in full legal force and effect.
6. **Acknowledgment of Understanding:** I have read the previous paragraphs and I understand and appreciate these and other risks that are inherent in The Event. I assert that my participation is voluntary and that I knowingly assume all such risks. I also understand that I am giving up substantial rights, including my right to sue to TFASC. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent the law allows. Wherever in this document the term TFASC is used, the term shall include all of its trustees, officers, staff members, employees, and agents.
